
Please see the brochure listed below published by the Indiana Department of Natural Resources regarding this invasive species of fish that decimates the fish population in a body of water once invaded. We can prevent this type of invasion by never bringing in fish or releasing baitfish from other bodies of water. To prevent the distribution of their eggs it is best to empty and clean your well before bringing your boat back to Schaefer Lake from another body of water. www.IN.gov/dnr. Click on Aquatic Invasive Species (AIS) and go into "Stop The Invasion" to view the entire brochure. It is unsure whether Asian Carp would survive long term in a small lake such as ours by reviewing the DNR information but it is something to consider and pay attention to.



Another invasive species is the zebra mussel. These mussels will attach themselves on watercraft and then infect our lake if given the chance. They are a problem as they eat large amounts of phytoplankton and zoo plankton thus disrupting the food chain for other fish and wildlife. They attach to turtles and eventually kill them. They attach to rocks and hard surfaces, clogging drain lines and damaging engines by layering. Their eggs are able to remain suspended in water for 3 to 4 weeks. For this reason it is important that water from other bodies is not brought into Schaefer Lake. Please go to www.in.gov/dnr/files/zebra-mussel.pdf for more details.

Please visit http://www.in.gov/dnr/files/zebra-mussel.pdf to see how to prevent accidentally bringing zebra mussels to Schaefer Lake. It is most important to keep water from other bodies from entering our lake. Empty wells onto the land – not water. The DNR recommends you flush the cooling system and live wells and then let the boat dry for five days. If it is necessary to put the boat in the water sooner, they recommend washing everything down with a 5% bleach solution.

<u>Did you Know</u>. Our lake has been tested for ecoli contamination 3 times this summer. The results have been very low. On July 25th our result was less than 1 mpn/ml. The EPA limit is 235 mpn/m;.Mpn means "most probable number" of bacteria present. We are investigating methods of bacteria and algae testing.
