

### GREEK CHICKEN GYROS WITH TZATZIKI SAUCE

- Chicken Marinade:
- 2 lbs. Chicken Breast, cut into pieces
- <sup>1</sup>/<sub>4</sub> cup Greek Yogurt
- 3 Tablespoons Fresh Lemon Juice
- 2 Tablespoons Extra Virgin Olive Oil
- 1 Tablespoon Red Wine Vinegar
- 1<sup>1</sup>/<sub>2</sub> teaspoon Salt
- 1 teaspoon Pepper
- 2 teaspoons Oregano
- •
- Tzatziki Sauce:
- 1<sup>1</sup>/<sub>2</sub> cups Greek Yogurt
- 2 Tablespoons Extra Virgin Olive Oil
- 1 Tablespoon Lemon Juice

- 1 Tablespoons Red Wine Vinegar
- 1-2 teaspoons Salt
- 1 Tablespoons Fresh Dill, diced
- 3 Garlic Cloves, finely diced
- 1 cucumber, grated and squeezed to drain

- Greek Salad:
- 3 Tomatoes, diced
- 2 Cucumber, peeled and diced
- <sup>1</sup>/<sub>4</sub> Red Onion, diced
- 2 Tablespoons Fresh Italian Parsley, diced
- 1 Tablespoon Extra Virgin Olive Oil
- Salt and Pepper, to taste
- Feta Cheese

- 4-6 Greek Pita Breads, Naan bread, or Flatbread

### INSTRUCTIONS

- 1. Place chicken, yogurt, lemon juice, olive oil, vinegar, salt, pepper, and oregano in bag and let marinate at least 30 minutes, preferably 2-4 hours. The ideal time is 24 hours.
- To make tzatziki sauce, stir together yogurt, olive oil, lemon juice, vinegar, salt, dill, and garlic. Stir in grated cucumber and taste for seasonings. Squeeze the cucumber to remove excess water before adding to rest of ingredients.
- 3. To make greek salad, place tomatoes, cucumber, red onion, parsley, olive oil, salt and pepper in bowl. Stir to coat. Season to taste.
- 4. Chicken can be cooked on grill or in skillet. To cook on grill -- place chicken on kebobs and heat grill to medium heat. Cook for 5-7 minutes per side or until chicken is full cooked.
- 5. To cook chicken on skillet. Heat skillet to medium high heat. Sprinkle with oil. Add chicken and cook for 8-10 minutes, or until chicken is fully cooked and golden brown.
- 6. Place chicken in pita bread. You can warm the pita bread to make it pliable. Top with tzatziki sauce and greek salad. Add additional feta, if desired.

Gentle reminder: Consider weigh distribution when loading your pontoon. These boats do have a maximum capacity and weight should be evenly distributed, not overly heavy in the front which could cause the front to nosedive when underway.



### **Boating Tips**

Continuing last month's research on recommended boat speeds for various water sport, in the USA Waterski "how to" documents, they provide this handy reference for boating signals between the driver and someone being towed:



- **1. Speed up**: The "thumbs-up" gesture indicates that the rider would like the speed increased.
- 2. Slow down: The "thumbs-down" gesture indicates that the rider would like the speed decreased.

3. OK: If the set speed or boat the path is good, the rider may use the OK signal.

**4. Turn:** When either the rider or the driver wants the boat turned, a circle motion with the arm over the head with one finger in the air is used. It is usually followed by pointing in the direction of the turn.

5. Back to the Dock: A pat on the head indicates that the rider would like to return to the dock.

**6.** Cut Motor/Stop: A slashing motion with the hand across the neck indicates the boat is to stop immediately. This signal can be used by the rider, driver or observer.

**7. I'm OK** (after a fall): This important signal indicates that a rider is OK after a fall. It consists of both hands clasped over the head. It should be used every time the rider falls.
