# Hope's biggest fireworks display fills July 3 sky over Schaefer Lake

## Third annual show held in memory of Diane Hawes

The biggest fireworks show in Hope got started two years ago when a few Schaefer Lake neighbors pooled their efforts to put on one large show during the July 4 holiday.

Since 2020, the Schaefer Lake fireworks display has been spearheaded by Cody and Rikki Hege, Craig Hawes and his late wife Diane, and Jacob and Carrie Trotter as the core group, with others joining in to support the effort the past two years.

It was Diane Hawes' idea for



the families to work together, and to shoot off the display from the home where she and Craig moved into in late 2016 – near the midpoint of the lake.

"She was the ram-rodder," said Cody Hege, who moved to the lake with wife Rikki in 2011.

Hege and Jacob Trotter, who moved to Schaefer Lake in 2012 with wife Carrie, light the fireworks with the help of a few others.

This year's show – held on evening of July 3 -- was dedicated to the memory of Diane Hawes, who succumbed to cancer at age 62 on Sept. 9, 2021 after having been cancer-free for five years.

Some of Diane's favorite songs were played during this year's fireworks presentation.

"Diane loved the fireworks," Hege said. "That's why we tried to go above and beyond this year."

Hege lit \$1,000 to \$1,500 in fireworks from a 16-foot fishing boat from 2015-2017, then from his cove in 2018.

"I've always done little shows, nothing like the last few," he said.

For the 2021 show, the annual fireworks investment had risen to about \$6,000, Hege said.

With a goal to make the 2022 show even bigger, they purchased and set off about \$7,000 in fireworks this year, he said.

That bought about 250 fireworks, including "grand finale" mortars that shoot high into the sky with 10 to 20 shots in them, Hege said.

They went from five mortars last year to at least 10 this year, Hege said.

"It just kept going and going," he said of this year's grand finale.

Appreciative neighbors made sure of that with their donations.

"I had 4 to 5 people hand me money this year. I had a lot of help," Craig Hawes said.

The organizers' goal was to present a 60-minute show this year, he said, compared to last year's show of about 52 minutes.

They came close at 59 minutes.

With all the smoke and commotion in pitch-black conditions, some fireworks – enough to push the show to an hour in length – never got lit, Hawes said, but the crowd was unaware.

"Best fireworks show in the 40 years that I've lived out here," lake resident Donnie Graham had said of the 2021 show.

After this year, Graham remarked: "I thought it would be hard to beat last year's show, but you sure did it! Thank all of you!"

That's due to the increase in lake neighbors stepping up to help, organizers said.

"They get better each year. We're glad everybody enjoyed it. We enjoy doing it and appreciate everybody throwing in to make it better each year," Hege said.

"We exceeded all of our expectations and I was very happy," Hawes said. "It was a ton of fun. My family enjoys it. I'm happy other families get some joy out of it too."

It took a half day to clean up after the fireworks, with debris filling a full-sized dumpster, Hawes said.

That was possible only because 10-12 people showed up on July 4 to help with the cleanup.

"I couldn't have done it myself," Hawes said. "It was very cool. More and more of the neighbors are getting into it and getting supportive."

With the show's central location on the lake, neighbors had excellent views from lawn chairs in their back yards, from pontoons parked in the middle of the lake and from property across the lake.

Videos from this year's event have been posted on at least three different media channels – and word is spreading, Hawes said.

"Last year Hope police called me next day and asked for advance notice so they could help with traffic," Hawes said.

This year, the department provided four squads to patrol the area and help with traffic, even though Schaefer Lake is outside the town's jurisdiction, he said.

"Hundreds and hundreds of other people saw the show" from cars parked around the lake, besides the lake residents it was originally intended for, Hawes said.

"It's turned into a neat little spectacle," he said.

# Boating, Skiing, and Fishing Rules and Regulations OF SCHAEFER LAKE LOT OWNERS ASSOCIATES, INC.

The Schaefer Lake Lot Owners Associates (hereinafter referred to as the "Association"), per Article III of the Bylaws to the Articles of Incorporation, has the responsibility and authority to adopt and publish rules and regulations governing, regulating, and restricting, the use of Common Area(s) and the personal conduct of the members and their guests thereon and also to regulate, govern, and restrict the use of boats, motors, and water safety on Schaefer Lake.

These rules and regulations are intended to promote the common benefit and enjoyment of Association members and the residents of Schaefer Lake. To that end, courtesy and respect for the rights of others should be shown at all times.

All lot owners are subjected to these rules and regulations. Members may extend their privileges to their family and guests and are responsible for their awareness and compliance with these rules and regulations.

Persons in violation of these rules and regulations will be notified by letter and provided an opportunity for a hearing with the Board of Directors. The Board may impose fines and/or restrictions on the use of Schaefer Lake.


These rules and regulations are based on and consistent with the Laws of the State of Indiana, specifically Indiana Boating Laws and Responsibilities (IBL&R) (IC 14-15) and Indiana Fishing Regulations.

#### I: Boating

- 1. A watercraft is defined as any vessel, powered or non-powered, such as but not limited to, speedboat, pontoon boat, fishing boat, personal watercraft (PWC), sail boat, kayak, canoe and paddleboard.
- 2. Watercraft shall operate safely at all times, even when there is no specific rule that applies. A person may not operate a watercraft in manner that unnecessarily endangers the person or property of another person. (IBL&R)
- 3. All powered watercraft are required to be registered with the Association, per the Watercraft Registration Policy. The registration sticker must be displayed on the right rear corner of the watercraft.
- 4. No "guest" watercraft, powered or non-powered, are permitted on the lake at any time, except for the purpose of test driving a watercraft. Test drives will be limited to one hour and the member shall notify the Secretary of the Board of Directors.
- 5. Each lot owner is permitted up to four powered watercraft, such as but not limited to, speedboat, pontoon boat, fishing boat, and PWC.
- 6. Watercraft are limited to less than 26 feet in length (tip of bow to stern).
- 7. All watercraft must carry one wearable (Type I, II, III or V) U.S. Coast Guard-approved personal floatation device (PFD) for each person on board or being towed. (IBL&R)
- 8. Watercraft 16 feet in length or longer (except a canoe or kayak) must have one Type IV (throwable) USCG-approved PFD on board and readily accessible. (IBL&R)

- 9. Each person on board a PWC must wear a PFD. (IBL&R)
- 10. No one under 15 years of age may operate a motorboat greater than 10 horsepower or a PWC unless accompanied by a lot owner.
- 11. All powered watercraft shall proceed in a counter-clockwise fashion and use extreme caution when crossing the lake. (Direction may vary when fishing from lake bank side.)
- 12. Non-powered watercraft have the right of way at all times.
- 13. Operating a watercraft at more than idle speed between sunset and sunrise is prohibited. (IBL&R)
- 14. All watercraft are restricted to idle speed within 50 feet of the shoreline. (IBL&R)
- 15. All watercraft must maintain safe and clear distance from other watercraft and skiers.
- 16. Allowing passengers or operators to ride on the gunwale or on the bow where they may fall overboard is not permitted. (IBL&R)
- 17. Operating a watercraft causing a hazardous wake or wash from your watercraft is prohibited. (IBL&R)
- 18. Lights are to be used on all watercraft approximately 30 minutes before sunset and ending 30 minutes after sunrise. Reference *The Handbook of Indiana Boating Laws and Responsibilities* for proper navigation lights.
- 19. It is prohibited to operate a powered watercraft or PWC while intoxicated due to alcohol or any combination of alcohol, controlled substance, or drugs. It is prohibited for owners of motorboats or PWCs to operate or allow anyone else to operate their motorboat or PWC while that person is intoxicated. (IBL&R)
- 20. Racing boats and racing of watercraft are prohibited.
- 21. Maximum speed shall be reasonable and prudent for traffic and lake conditions.

#### II: Skiing

- 1. A skier is defined as anyone riding a water ski (or barefoot), tube, or other floatation device.
- 2. All skiers are to remain at least 50 feet from the shoreline and other traffic.
- 3. All skiers must wear a USCG-approved PFD. (IBL&R)
- 4. Every boat or PWC towing a skier(s) must have a person on board, in addition to the operator, observing the skier(s) at all times. (IBL&R)
- 5. Each lot shall be restricted to one watercraft towing skiers on the lake at a time.
- 6. No watercraft shall tow more than two ski lines, i.e., skiers or towables, at any time.
- 7. The slalom ski course shall be removed by noon on summer holiday weekends: Memorial Day, Independence Day and Labor Day.

#### III: Fishing

- 1. Indiana Fishing Regulations apply to fishing on Schaefer Lake except as noted below.
- 2. No fishing license is required.
- 3. No size or bag limits apply.
- 4. Only members and their guests accompanied by a member are permitted to fish in the lake.
- 5. Commercial fishing is prohibited.
- 6. Placing fish in the lake for stocking purposes is prohibited.

- 7. Use of seines, traps (except minnow traps), gigs, fire arms, pellet and air guns, explosives, shocking devices, arrows, spear guns, trot lines, limb or drop lines, and other similar devices is prohibited.
- 8. Unattended lines secured to docks, etc., are not permitted.

#### **IV:** Miscellaneous

- 1. No traffic, including fishing, swimming, etc., shall be permitted on the dam and spillway.
- 2. Deposit of debris, waste or trash of any kind into the waters of the lake is prohibited. This includes trees, limbs, and leaves. It is also the responsibility of any lot owner to remove all fallen trees, limbs, etc., that came from their property.
- 3. It is the responsibility of the lot owner to remove, at their expense, any boat house, boat lift, or pier that is unsafe for use.
- 4. No hunting shall be permitted on the lake at any time.
- 5. Firearms shall not be discharged on, onto, or across the lake. B-B guns or other potentially dangerous weapons for varmint control should be used with extreme caution and with due respect for the safety and peace of mind of others.
- 6. The Association Safety Committee has the responsibility and authority for ensuring member safety in all common areas. Safety issues, especially disregarding boating regulations and operating unauthorized boats, should be reported to a safety committee representative or Board member and they will administer appropriate corrective action. Each lot owner has the responsibility to preserve the safety of our lake.
- 7. Persons in violation of these rules and regulations will be subject to fines following one written warning (annually), and having had an opportunity for a hearing with the Board. A \$50 fine may be imposed for the second offense and up to \$500 for subsequent occurrences.

These rules and regulations were approved by the SLLOA membership in 2018.

Treasurer's Report and Financial Update (Jen Hellmich)

- A total of \$100,500 has been taken in -- \$99,000 in 2022 dues and \$1,500 in past 2021 dues, providing a SLLOA bank balance of \$519,767.

Update on Dredging (Ken Miller and Scott Towsley)

Conversation with second silt-deposit property owner has progressed with generally positive interest in being a secondary deposit site. Here are their questions, with board's answers.

How much silt will be dredged from the lake? 125,000 cubic yards Who will be doing the soil testing? Heartland can arrange testing Who will be doing the mowing? SLLOA will arrange.

**Does Heartland have a dredging plan?** Upon commissioning of the contract, Heartland would submit a plan for the site to the DNR outlining the operation, the site, where the material is going, the silt-retention plan, erosion-control plan, etc. Heartland has created a document for the LOA to help them understand how he would use their land. Example: Layout of the berms, height of the berms, path of the pipe, location of the weir, path of the drainage water, etc. We thought this latter document was a good place to start to address their request for a "dredging plan." Mark will complete this document by June 17.

What entails the post-deposit maintenance, Round-up or seeding with grass? When Heartland is preparing to leave the site, they will remove the boards in the weir that set the depth of the water in the settling area. When the remaining water exits, they put bales of hay and/or an erosion-control fabric to help filter the water as it exits the basin. This will remain until the silt drains out. Rain will collect in this low spot in the retention area. He mentioned that fairly quickly, the seeds that are present in the silt will start to sprout and grow. This is good as the roots will stabilize the soil and plants will help with absorbing the moisture. He thought seeding with a grass would also be good for the same reasons. The grass will also help with structure to support someone mowing the area. He did say it would be in our best interest to mow somewhat frequently to prevent tree growth. In summary, we should plant grass seed and arrange to have it mowed.

What does Heartland's current 2023 spring schedule look like? Heartland has two contracts for dredging this year, Lake Lemon and a smaller job. Based on their progress and setup time at Lake Lemon, they do not think they will get the second smaller job completed this year and will start on it March 2023. He thought the earliest for our project to start would be May 1, 2023.

- Results of September water sampling: E.coli results from Inlet 4, Middle 3 and Dam 2 were much lower than federal guidelines to meet the low classification.
- Concern voiced by a lot owner about rip-rap vegetation becoming out of control at certain lots. Overgrowth can restrict the view and pleasantry of the lake property for immediate neighbors and the lake community. Each lot owner should assess their respective condition of the rip-rap and perform any necessary maintenance and cleanup.
- In August a lot owner brought to the attention an orange weed that seems to be growing rapidly on the rip-rap. The board reached out to Aquatic Control (the company we hire to treat the lake for vegetation and algae control). Their assessment was the weed is Dodder. The herbicide to kill it is not safe for the lake. In their experience it has not been a problem at other lakes they maintain.
